**All Vehicles and Parts and Swap Items Must Be Removed By 3:00 pm Sunday**

**General Rules, Policies, and Springfield Ordinances:**

- **No Parking , Loading or Unloading at any time in FIRE LANES.**
- **NO SMOKING ALLOWED IN ANY PART OF E-PLEX, GRANDSTAND , OR ANY OTHER INDOOR FACILITY, BY CITY ORDINANCE.**
- **ILLEGALLY PARKED VEHICLES WILL BE TOWED AT OWNERS EXPENSES,** Limited loading & unloading is permitted during appropriate times.
- **Camping in West Parking not permitted per City ordinance.**
- Motel accommodations nearby \* Refreshment stands on the grounds \*
- **NO MOTOR DRIVEN VEHICLES FROM 10am until 4pm - NO BICYCLES, SKATES, SKATE BOARDS OR SCOOTERS, ETC.**
- Wheelchairs and handicap scooters that are allowed by ADA can be used at any time - **SPEED NOT TO EXCEED 5 MPH.**
- Vendors are not permitted to sell or give free refreshments by Springfield Ordinance
- **No sale or exhibition of firearms is permitted by Springfield Ordinance**
- Alcoholic beverages are permitted only in designated areas on the fairgrounds.
- All pets and service animals must be on a leash at all times.
- **THE OAAC is NOT RESPONSIBLE for ACCIDENTS AND/OR THEFT**

**E-Plex Rules, Policies, and Springfield Ordinances:**

- E-Plex[Exhibit Halls] Vendor Set up will be Thursday afternoon unless otherwise announced.
- ***E-Plex overhead doors will remain closed from Thursday night until Sunday afternoon.***
- E-Plex vendors must confine all activities to their rented space. No alterations to building or property. No tape on walls. Vendors must provide tables, chairs, display racks, table draping and set up supplies. Fairgrounds will rent tables & chairs, call 417-833-2660 for information.
- E-Plex opens at 7:00 am and closes at 7:00 pm, Vendors set own hours. Vendors can get in at north doors at 6:30 am.
- No animals or pets in E-Plex except service animals. Service animals must be on a leash at all times.
- E-Plex vendors cannot obstruct water fountains, rest rooms, exits or concessions.
- E-Plex Vendor Merchandise and equipment must be removed by 3:00 pm on Sunday. All items and trash to be removed from space.

**Main Swap Grounds Rules, Policies, and Springfield City Ordinances**

- Swap Meet Vendor Set up will be Thursday afternoon unless otherwise announced.
- **5 mph SPEED LIMIT for all vehicles ON GROUNDS.**
- **GATES WILL CLOSE AT 3:00 PM SUNDAY—Vendors MUST vacate grounds by 3 pm Sunday.**
- Grounds guarded 24 hours a day..
  - Windshield stickers must be displayed on upper left corner of windshield, below the tinting.  
**YOU WILL NOT BE ADMITTED WITHOUT STICKER ON WINDSHIELD. ALL VEHICLES MUST BE ON SPACES**
- Limited vendor camper hook-ups available only inside swap meet area.
- No open fires at any time.
- To prevent noise during sleeping hours, absolutely no motor traffic will be allowed between 10pm and 6am in the swap meet area. Gates will be closed and officer will be on duty.

**CAR CORRAL RULES AND POLICIES:**

- No **parts** are to be displayed or sold in the car corral. Parts that belong with the vehicle being sold must be inside the car or on the trailer with the car.
- . Car Corral cars must have sticker on it at all times. Riding around inside swap meet is not permitted. **GATES CLOSE AT 3PM SUNDAY, ALL CARS MUST BE REMOVED BY 3;PM.**
